Dagsboro Hundred Residents Who served in the Delaware Military During the Revolutionary War

Stephen Bell, Private, Haslet's Regiment, 1776

Stephen Bell served as a Private in Haslet's Regiment, enlisting January 18, 1776 and being present at muster at the barracks at Lewes DE on April 11, 1776. Stephen Bell was born February 12, 1753 in Worcester County MD. His parents were Isaac and Ann Bell. The estate of Stephen Bell was probated in the period 1783-5. The administrator of his estate was Ann Bell. The administration bond of the estate dated September 1783 named Ann Bell and William Day as administrators. The inventory of the estate dated September 29, 1784 was completed by Samuel Lockwood and Armwell Long. Samuel Lockwood and Armwell Long were both residents of Dagsboro Hundred in 1790. No evidence has been found for the burial of Stephen Bell.¹


Jacob Burton, Private, Hall's Regiment, 1778 – 1782

Jacob Burton served as a Private in Hall's Regiment. He enlisted May 11, 1778 and was present at muster at White Plains NY on September 2, 1778. He was present at the camp at Wicks Farm NJ on March 7, 1780, and he was present at Christiana Bridge on May 2, 1780. He was discharged in June 1782.

Jacob Burton has been identified as a resident of Dagsboro Hundred and as having a birthdate of July 21, 1751 and a death year of 1807. The composition of the 1800 household of Jacob Burton is shown in the table below:

The petition of Sophia Burton, widow of Jacob Burton, contained in the Orphans Court file of the estate of Jacob Burton states that Jacob herself and 7 children and that he died intestate possessed of 600 acres in Dagsboro Hundred. The seven children are identified as Jacob Burton, Ebenezer Burton, Sally Ingram widow of Job Ingram, Isaac Burton, Anna Ingram, Wiliam Burton and John Burton. An image of the 1807 survey map of the lands of Jacob Burton is shown below:



The stream along the boundary is labeled Indian Branch; the widows dower, shown near the center of the property, contains a house near Indian Branch and 151 acres. No information has been found for the burial of Jacob Burton.²

John Dagworthy, General Delaware Militia

John Dagworthy served as a Brigadier General in the Delaware Militia. He was commissioned on September 11, 1775 and was appointed to command a Brigade from

Sussex County in the Delaware Militia. He served from 1775 - 1780. John Dagworthy was taxed in the Dagsboro Hundred in the period 1778 - 1780. The will of John Dagworthy, Esq. was dated June 18, 1781 and his estate was probated May 24, 1784. His wife Martha was one of the executors. No children were mentioned. Inventory of the goods and chattels of the estate yielded a total value of £1,053, 8s, 0p. the administration account done by Martha Dagworthy resulted in a net balance to the estate of £2,874 13s 0p. John Dagworthy died May 1, 1784 and is buried in the Prince George's Cemetery in Dagsboro DE.³

Aaron Eason, Private, Hall's Regiment, 1777 – 1783

Aaron Eason served as a Private in Hall's Regiment in the period 1777 to 1783. He was present at the battles of Guilford, Cowpens, Camden, and Little York. He was also present at the taking of Cornwallis. He was discharged at New Castle DE in 1783. In his declaration for his pension dated April 30, 1821, Aaron Eason stated that he was 80 years old and a resident of Dagsborough Hundred. Fellow Sussex County veterans Mitchell Lecatt and Edward Harmon made depositions supporting his application for a pension based on his service. Aaron Eason died in March 1823. No evidence has been found for his burial.⁴

Ezekiel Hitchens, Private, Peery's Company, 1777

Ezekiel Hitchens served as a Private in Captain Peery's Company stationed in Lewes DE. He enlisted May 6, 1777 and was present at muster on June 2, 1777. Ezekiel Hitchens was taxed in the Dagsboro Hundred in 1779. The estate of Ezekiel Hitchens was probated November 3, 1783. The executors were his widow Sarah Hitchens and Hap Hazzard, his friend, and heirs were his wife and daughters Comfort and Aletty. The inventory of his estate was completed by James Fisher on September 5, 1784. No information has been found for his burial.⁵

Simon Kollock, Lt. Colonel, Neill's Regiment, 1778-83, Patriotic, 1780 - 1783

Simon Kollock served as a Major and Lt. Colonel in the Delaware Militia in the period 1775 - 83. He also served as Speaker of the Delaware House of Assembly in the period 1780 - 1783. Simon Kollock died in 1817 and is buried in the Old Saw Mill Meeting House Cemetery in Millsboro DE.⁶

William Newbold, Ensign, 2nd Delaware Regiment, 1780

William Newbold served as an Ensign in the 2nd Delaware Regiment commanded by Col. Henry Neill. He received his commission on July 14, 1780 and was on the payroll for Captain George Smith's Company, Neill's Regiment dated October 31, 1780. William Newbold was identified as a resident of Sussex County at the time of his commission. William Newbold was the son of William Newbold whose will was dated April 28, 1777. William Jr.'s mother was Margaret Newbold.

William Newbold was taxed in the Dagsboro Hundred in 1780. He appears in the Reconstructed 1790 census of Delaware in both the Dagsboro and Lewes and Rehoboth Hundreds. While this could indicate 2 different men named William Newbold, it is also possible that these 2 records refer to 1 man. The Reconstructed census was created from tax records, so it is possible William Newbold owned property in both hundreds.

William Newbold was named executor of his mother Margaret's estate. The will of Margaret Newbold, dated May 4, 1789, names her heirs as daughters as Esther Thorogood, Margret Ingram, and Mary Hood, and her son William Newbold. There is only one probate record in Sussex County during the post Revolutionary period for William Newbold. His estate was probated in the period 1800 to 1807. There is no census record for William Newbold in Delaware in 1800. The will of William Newbold identifies these heirs: wife Mary, nephew John Ingram, nephew William Hood, son of Robert Hood, nephew John Thorogood son of John Thorogood and sister Esther.

Comparison of the heirs of mother Margaret Newbold and son William Newbold reveals that several family members are mentioned in both wills. Robert Hood was married to William's sister Mary Newbold and John Thorogood was married to William's sister Esther Thorogood. The William Newbold in Margaret's will was clearly the William who died in 1800. No other probate record for a William Newbold has been found in this era in Sussex County. This supports the conclusion that William Newbold who served in Hall's Regiment was a resident of Dagsboro Hundred. No information has been found for the burial of William Newbold.⁷

John Piper, Ensign, 2nd Delaware Militia, 1780

John Piper served as an Ensign in the 2nd Delaware Regiment of Militia. He was commissioned as an Ensign on August 5, 1780 to serve until November 1, 1780. He appears on a muster roll of Captain William Moore's Company dated August 12, 1780, and on a pay roll of the same company dated October 31, 1780. John Piper was taxed in the Dagsboro Hundred in 1778, 1779, and 1780. The will of John Piper, dated January 11, 1786, names his wife Elizabeth as executor, and names sons William and Benjamin, daughter Lovey, and Elizabeth's unborn child. The inventory of the estate was completed March 10, 1786 by William Swain and Moses McDaniel, who were also witnesses to the will of John Piper. The total value of the inventory was £61, 6s 4 ½ p . Elizabeth Piper, acting as executor of the estate, sold 100 acres of land in Dagsboro Hundred in 1792 that had been obtained by her late husband by a Proprietary Warrant dated March 12, 1776. No evidence has been found for the burial of John Piper.⁸

Robert Prettyman, Sergeant, Peery's Company, 1776-7

Robert Prettyman served as a Sergeant in Captain Peery's Company stationed in Lewes DE. Robert Prettyman, Patriot, was identified as a Resident of Dagsboro Hundred. He paid taxes in the Dagsboro Hundred in the period 1778-80 and he was a resident of Dagsboro Hundred in 1790. The will of Robert Prettyman of Dagsboro Hundred was dated May 12, 1809, and his estate was probated June 6, 1810. His wife Mary and his son Joseph were co-executors. Other children mentioned in the will were sons Thomas, Warren, Robert, Job, John, Eli, and Richard. No evidence has been found for his burial.⁹

Ayedelott Salmons, 2nd Delaware Regiment, 1780

Solomon Salmons, 2nd Delaware Regiment, 1780

Ayedelott and Solomon Salmons were 2 brothers who served together in Captain William Moore's Company of the 2nd Delaware Regiment commanded by Col. Henry Neill. Aydelott Salmons enlisted on August 5, 1780 in the 2nd Delaware. His name appears on a list of casualties and he was discharged on September 13, 1780. Solomon Salmons was engaged on July 10, 1780 and his name appears on 2 rolls for Captain Moore's Company: a muster roll dated August 12, 1780 and a payroll dated October 31, 1780.

Aydelott and Solomon Salmons were the sons of Benjamin and Agnes Butcher Salmons. The sons of Benjamin and Agnes Salmons were Benjamin, the eldest, William, Solomon and Aydelott. Benjamin Jr. inherited his father's land. Benjaman Sr. died in 1775. In 1776, Benjamin Jr. had 100 acres of land in Dagsboro Hundred resurveyed. Benjamin Salmons was taxed in both the Dagsboro and Indian River Hundreds in 1778 and 1779. William Salmons was taxed in the Dagsboro Hundred in 1779. The evidence is sufficient that Ayedelott and Solomon Salmons were residents of Dagsboro Huntred.

The estate of Ayedelott Salmons was probated in the period 1784-5. The executor of his estate was his brother William Salmon. No heirs were identified. No information has been found as to his burial. The estate of Solomon Salmons was probated on October 29, 1830. His executor was William Salmons. No information has been found as to his burial.¹⁰ **Eli Waples, Corporal, Hall's Regiment, 1782-3**

Eli Waples served as a Corporal in Hall's Regiment. He was recruited by Captain James Moore in Lewes DE on February 7, 1782. He received rations in July 1782. He was declared fit for duty on a muster roll December 28, 1783 in Philadelphia. The estate of Eli Waples was probated in the period 1785-6. The estate inventory was completed December 3, 1785 by Simon Kollock and William Butcher. Simon Kollock was a resident of Dagsboro Hundred and served as a Major and Lt. Colonel in the Delaware Militia in the period 1775 – 1783. No information on the burial of Eli Waples has been found.¹¹

John Watson, Quartermaster, Patterson's Flying Camp Battalion, 1776

John Patterson served as Quartermaster in Patterson's Flying Camp Battalion in 1776. John Watson was taxed in the Dagsboro Hundred in 1778 and he was a resident of Dagsboro Hundred in 1790. The inventory of the estate of John Watson, completed November 1, 1793, showed a total value of £15 9s 1p. The administrator of his estate was William Sammons. No information has been found for his burial.¹²

William Warrington, Corporal, Haslet's Regiment, 1776

William Warrington served as a Corporal in Haslet's Regiment in 1776. He enlisted on January 16, 1776 and was present at the barracks at Lewes DE on April 11, 1776. Three probate files for the estate of men named William Warrington in Sussex County have been found:

1. The will of William Warrington was dated January 20, 1755. The will names 4 sons: William, Benjamin, John, and Joseph, and 5 daughters: Comfort and her two children William and Lewis Davidson, Tilney, deceased, who left 3 children including a daughter Tilney, Susannah Verdin, Vallance, and Ann. The will names his wife as Mary. The witness of this will were William Day, Jacob Wroughton, and Benjamin Stockly. William Day was the husband of Vallence Warrington. Benjamin Warrington received a land warrant in "the forest of Indian River" in 1760. A witness to this warrant was William Day. Luke Warrington was a resident of Indian River Hundred in 1800.

The inventory of the estate of William Warrington was completed November 27, 1794 by Joseph Waples and Marcel Ciligo. Joseph Waples was a resident of Indian River Hundred in 1790. The value of the inventory was £81 7s 2p. John Lingo completed the administration account on August 23, 1796. The balance due the estate was £88 6s 3 ½ p. The evidence is sufficient to conclude that the William Warrington who wrote his will in 1755 was a resident of Indian River Hundred, and that he had a son named William.

The second file contains only the will of William Warrington was dated August 30, 1782.
This will bequeaths to his eldest son Luke part of the plantation where William lived on

the road from St. George's Chapel to the Doe [?] Bridge. His second son Levi was bequeathed part of the same plantation. Youngest son William also received part of the plantation as well as the responsibility to provide for his mother. Son Benjamin received a share of the plantation. Luke was named executor. Witnesses were Robert Prettyman, William Prettyman, and Milajah Davison. William Warrington and Luke Warrington were taxed in the Indian River Hundred in 1780. This was likely William the father.

3. The inventory of the estate of William Warrington, Shop Joyner, was completed May 4, 1816. The total value of the inventory, completed by Joshua Burton and Levi Hill, was \$591.38. The administration account completed by Eli Parsons and Sarah wife of William Warrington on June 21, 1824 showed a net balance of \$254.05½. There was a William Warrington who was a resident of Dagsboro Hundred in 1800. This must have been the William Warrington who died c. 1815 because the other William was already deceased.

Based on the evidence found, the William Warrington who was a Corporal in Haslet's Regiment was the William Warrington, Joyner who died c. 1815. The William Warrington who had a will dated 1755 also had adult children in 1760, thus was likely too old to serve as a soldier in 1776. William the soldier was a son of William of Indian River per the will records. William the son lived in Dagsboro Hundred as an adult according to the census record. No evidence for his burial has been found.¹³

William Wright, Private, Haslet's, 1776

William Wright served as a Private in Haslet's Regiment in 1776. He enlisted on February 16, 1776 and was present at muster at the barracks at Dover DE on April 12, 1776. He was a resident of Dagsboro Hundred in 1790. The will of William Wright, dated July 26, 1798, named

his sisters Betsey Wright and Polly Wright as his sole heirs. He named his friend Thomas

Robinson as his executor. The testamentary bond for Thomas Robinson was dated July 31, 1798.

The inventory of the estate, completed by Isaac Cooper and Samuel Williams, dated August 3,

1798, showed a total value of £127 4s 5p. The administration account completed by Thomas

Robinson on March 4, 1799 showed a balance of £19 9s 6 ½ p. No evidence for his burial has

been found.¹⁴
