The Life and Family of Nicolas Whitman

Nicolas Whitman was born February 9, 1761 in Ashburnham Massachusetts to parents Christian William Whitman and Anistina Gross Whitman. Nicolas's parents were German immigrants. Nicolas Whitman married Elizabeth Rodiman 23 August 1781 in Asbhurnham MA. Elizabeth's father was also a German immigrant. Nicolas and Elizabeth Whitman's children, all born in Ashburnham, are shown in the table below:

After his service in the Revolutionary War, in 1782 Nicolas moved briefly to Warren New Hampshire.³ Nicholas moved back to Ashburnham and his father Christian sold his farm

there to him.⁴ Nicolas is listed on the 1798 tax list for Ashburnham.⁵ In 1814, Nicolas conveyed title to the farm to his son Jacob Whiteman in 1814.⁶

When Jacob Whiteman died in 1835, Nicolas stated in a court deposition that he was Jacob's sole heir, and that he wanted to be appointed executor of Jacob's estate. Instead, the Judge appointed another man executor of Jacob's estate.

On 10 December 1836, the Ashburnham Board of Selectmen filed an application to the Worcester County Probate Court to appoint a guardian for Nicholas Whitman due to his age and incapacity. Nicolas had a guardian appointed by the court. The guardian was

authorized by the Judge of Probate to sell the farm to provide funds for the care of Nicolas and Elizabeth Whiteman. In a statement in the probate file, Nicolas's daughter Nancy and son-in-law Ozias Partridge had asked to take care of Nicolas and his wife Elizabeth. ¹⁰ Per the note by the guardian at the bottom of the Partridge letter, Ozias and Nancy were the only family members who had communicated with Nicholas in the past ten years. Ozias and Nancy Partridge lived at that time in Reading New York, a town on Seneca Lake in the Finger Lakes region. ¹¹

Although in fact Peter Whitman, son of Nicolas and Elizabeth, was alive and living in Quebec, 12 the court accepted the statement of Nancy and Ozias Partridge and the probate court judge ordered Nicholas's guardian to sell the farm in Ashburnham to provide money to Nancy and Ozias Partridge to support Nancy's parents. 13

Nicolas and presumably Elizabeth Whitman were living with Nancy and Ozias

Partridge in Reading New York by the December 1837. The 1840 household of Ozias and

Nancy Partridge had this composition:

This evidence indicates that both Nicolas and Elizabeth were alive in 1840. They must have died some time prior to the sale of their son-in-law's land in Reading in 1849. Nancy Partridge resided in Tompkins County NY with her second husband William Clark in 1850. 15

No evidence has been found of the deaths or burial locations of Nicolas or Elizabeth Whitman. It is very likely they died in Reading NY, but there is no burial marker of
